COMPANY OVERVIEW

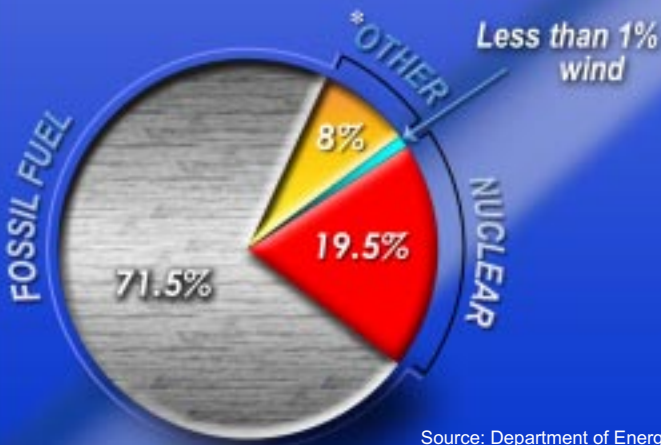
